APPLICATION FOR ELECTRIC SERVICE AND MEMBERSHIP

The undersigned (hereinafter called the "Applicant"), requests that the Cooperative investigate the possibility of promoting a rural electrification project so as to include the premises of the Applicant, and hereby applies for membership in the Union County Electric Cooperative, Inc. (hereinafter called the "Cooperative"), and in consideration of the acceptance of this application, the undersigned agrees with the Cooperative as follows:

- 1. The Applicant will pay to the Cooperative the sum of \$45.00, which sum if this application is accepted by the Cooperative, will constitute payment in full for membership (\$5.00) and a meter deposit (\$40.00), and such additional amounts that may be due and payable to the Cooperative as credit deposit.
- 2. The Applicant will, when electric energy becomes available, purchases from the Cooperative all energy used on the premises and will pay therefore, monthly at rates to be determined from time to time in accordance with the Bylaws of the Cooperative.
- 3. The Applicant will comply with and be bound by the provisions of the Articles of Incorporation and By-Laws of the Cooperative and such rules and regulations as may from time to time be adopted by the Cooperative.
- 4. The Applicant, by becoming a member in the Cooperative, assumes no personal liability or responsibility for any debts or liabilities of the Cooperative.
- 5. The acceptance of this application by the Cooperative shall constitute an agreement by and between the Applicant and the Cooperative and the contract for electric service shall continue from date service is made available by the Cooperative to the Applicant, thereafter until cancelled by notice given by either party to the other at least 30 days in advance.
- 6. The Applicant will cause their premises to be wired and maintained in accordance with wiring specifications as recommended by the National Electric Code, the State of South Dakota and this cooperative.
- 7. CONDITIONAL ASSIGNMENT OF CAPITAL CREDITS: In the event that the Applicant or his personal representative, shall fail to maintain their current address with the Cooperative at anytime such Applicant shall have accumulated any capital credits or refunds; and letters addressed and mailed to the Applicant with first class postage prepaid in the United States mail shall be returned over any period in excess of 36 months, then and only in such event: THIS HEREBY CONSTITUTES AN ASSIGNMENT of all capital credits or refunds then accumulated as a result of this Applicant's membership to the said Cooperative to be used by said Cooperative as donated capital.
- 8. The Applicant will allow access for construction, maintenance, clearance of trees or removal of lines if and when such might be necessary as determined by the Cooperative.
- 9. The Applicant agrees to contribute and pay to the Cooperative, as publisher of its member's journal. "Union County Electric Cooperative Connections", the monthly sum of fifty cents, or (\$6.00) per year for applicant's annual subscription to such publication, and authorize the Cooperative to deduct such sum from the annual amount of Patronage Capital accruing to Applicant.
